Search for missing Harper County man continues

The Barber County Sheriff's Office conducted a search on August 5, 2024 for a missing Harper County man, David Reese, 73.

The Kansas Bureau of Investigation issued a silver alert for Reese as requested by The Harper (KS) Police Department.

Reese was last seen on August 1, but investigators believe that he was in rural Barber County on August 2nd driving southbound on U.S. Highway 281 near Medicine Lodge at approximately 7:40 a.m.

It was reported by officials that "Reese is a white male who is 5 feet 11 inches tall and weighs around 250 pounds. He has brown eyes, a white beard, and is balding. He may be traveling with a chocolate Labrador retriever, and is likely wearing a baseball cap. Reese has diabetes, anxiety, and a condition impairing cognition and memory."

Ten agencies and more than 30 people participated in the search, which covered 700 miles, from Sharon to Aetna, over an eight hour time period. According to both the BASO and KBI's Facebook pages, "The search utilized aircraft, multiple drones, vehicles, and off-road vehicles. The area searched was over half of Barber County surrounding the last known location of Reese."

The BASO issued the following statement on Facebook, "We covered more than half of Barber County from Sharon to Aetna, where eyewitnesses have reported seeing the missing person. No signs of Mr. Reese or his possible route were uncovered. We will continue to investigate, as leads continue to come in. We greatly appreciate the public's assistance and the details reported. We have updated the surrounding counties and will continue the search. If you have any information about this situation, please call 911 immediately."

Agencies that took part in the search that was conducted included the Barber County Sheriff's Office, Harper County Sheriff's Office, Elwood Township Fire, Kansas Fire Marshall, Kiowa Police Department, Kansas Highway Patrol, Medicine Lodge Fire Department, Kiowa Fire Department, Barber County Rural Fire Department, and Barber County Emergency Management.



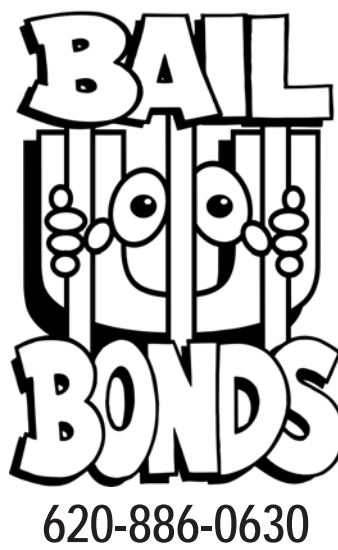
Community invited to SCCF's 30th anniversary gala
