The Board of Brown County Commissioners met in regular session on Monday, Sept. 16, with the following members present: Chairman Richard Lehmkuhl, Lamar Shoemaker and William Pollock. Also present was Brown County Clerk Nicole Lee. County Attorney Kevin Hill was present for a portion of the meeting. Lehmkuhl opened the meeting at 8:10 a.m. All recited the Pledge of Allegiance. Commissioner Lehmkuhl led the meeting with a prayer.

Tom Gudenkauf of P & J Solid Waste Management was present to express concerns about the new holiday and Saturday schedule at the Brown County Landfill that was approved at the last meeting.

Solid Waste Don Pounds presented an updated holiday schedule for the landfill. The remaining 2024 holidays for the landfill would be: Thanksgiving Day, Christmas Eve will close at noon and Christmas Day. The board approved the landfill holiday schedule as presented.

The board requested the County Counselor to draft a contract for the hauling of waste to HAMM with the contract ending April 1, 2025.

The commissioners agreed to a 10-minute executive session on non-elected personnel with the three commissioners, Pounds and Lee present to discuss personnel matters of non-elected personnel with an executive session necessary to protect privacy interests. No binding action was taken following the executive session.

Commissioners agreed to make the following personnel changes: Pounds will be Emergency Management/Solid Waste Director with an annual salary of \$56,000. Richard Rodvelt Noxious Weed Director, will receive monthly extra pay of \$350 for additional duties at the Solid Waste C&D Pit. Heather Merrill moves from Solid Waste Director to the position of

Solid Waste Operator IV. Brandon Rader, Solid Waste Operator V to Solid Waste Operator VII. Motion passed 2-1 with Commissioner Shoemaker voting nay.

Vicki Hubin and Chris Denner of Community Corrections, presented the commission with the agency's FY2025 Carryover Reimbursements Plan. The board approves the Adult and Juvenile Community Corrections FY2025 Carryover Reimbursements Plans.

The board approved the Sept. 9 meeting minutes with one correction.

The commission was presented with the Brown County Comprehensive Plan as approved by the Planning Commission. Additional concerns and changes will be sent to the Planning Commission.

The commissioners agreed to purchase a used 2020 Ford F350 Sprayer Truck from Shawnee County for \$48,000 and a \$700 transaction fee to Enterprise for a total of \$48,700.

The commission was presented with information from Resound Network on a broadband infrastructure project in Brown County and a request for a letter of support for the BEAD grant application. The board requested a Resound Network representative to be present to provide more information.

The board was presented with the following truck bed quotes for the Road and Bridge District 3 2024 Ford: Courtney's LLC for \$15,800, Triple C for \$13,747.20 and Wertzberger Ranch Equipment for \$17,221.50. The board agreed to purchase the District 3 truck bed from Triple C for the amount of \$13,747.20.

The commission was presented with results of the Brown County mid-year real estate appraisal/sales ratio study from Kansas Division of Property Valuation.

The Board of Nemaha County Commissioners met in regular session on Monday, Sept. 23, in the Commissioner's Room of the Nemaha County Courthouse. The meeting was called to order with Chairman Ben Glace leading the flag salute. Present also were Commissioners Dylan Keim and Jason Koch, County Administrator Mike Miller, and County Clerk Mary Kay Schultejeans recording the minutes.

Pastor Larry Danforth with the Sabetha Methodist Church led those present in an opening prayer to begin the meeting.

The board set the agenda with County Administrator Miller. The commissioners approved the agenda for Sept. 23 as presented.

Glace called for open public forum to begin at 9:17 a.m. No one came before the board to speak during the forum.

**Department Reports**

Road and Bridge/Solid Waste Supervisor Adam Kuckelman advised the board that:

- The guys are currently rocking F Road at this time.
- The graders are out on county roads following the rain received over the weekend.
- The new grader will be delivered today.
- The guys have started rocking N Road for the detour at this time.
- Kuckelman received trailer tire bids that he shared with the commissioners. Following discussion, the board approved the purchase of 16 trailer tires from Becker Repair and Performance at a total cost of \$5,944. The motion carried with all voting aye.
- Kuckelman received tube bids as well that he shared with the commissioners. Welborn Sales bid \$16,776.75 and Contech bid \$16,683.80. The commissioners approved the purchase of bands and tubes from Contech at a cost of \$16,683.80.
- The bridge department is putting in tubes and fixing wing walls throughout the county at this time.
- Hall Brothers will be here Wednesday to start on the Baileyville Road.

Emergency Preparedness Director Eddie Aldrine advised the board that:

- A mass casualty drill will be

held today beginning at 12:30 p.m. at the Nemaha Central Elementary and Middle School.

- Aldrine received bids for handicapped accessible doors at county buildings that he shared with the commissioners. The board made no decision on these bids at this time.
- Aldrine also received bids for door access control at county buildings that he shared with the board. The commissioners made no decision on these bids at this time.

Treasurer Janell Niehues and Deputy Treasurer Kim Bontrager came before the board and spoke to the commissioners about the 2025 budget request for the Treasurer's Office, about not rehiring for an open position in the Treasurer's Office, about implementing I-KAN for the processing of tax payments, and about cross-training county employees in the courthouse to help out in the Treasurer's Office when needed.

County Counselor Brad Lippert came before the board. The commissioners spoke to Lippert about the selling of supplies to local landowners. The board also spoke to Lippert about a dam safety inspection on a property that lies on a county road.

The board reviewed and approved the minutes as amended from the Sept. 16 meeting.

The commissioners reviewed the Nemaha County 2025 proposed budget suggesting changes to be made to lower the overall mill levy at this time.

The commissioners continued to work on the Nemaha County 2025 budget.

The board reviewed vouchers submitted by the different departments to be paid this week. The board approved the AP Warrants to be paid on Sept. 24 as presented.

The board appointed Marya Haverkamp to a three-year term on the Nemaha County Planning Commission to replace Lynette Strathman.

The commissioners appointed Brent Alverson to another three-year term on the Nemaha County Planning Commission.
