True, this is an unnatural play – deliberately losing a trick you can win relatively cheaply – but it's hard to dispute its merits. It guarantees the contract come what may, and who can find

fault with that? The best East can do is to continue with a heart at trick two, which leaves South on Easy Street. He loses the jack to West's king, but

there is nothing the defenders can do from this point on to defeat him. Even if West discontinues hearts, South can attempt the diamond finesse in complete safety. After East takes the king, he has no heart to return, and South winds up scoring three spades, four diamonds and two clubs to finish with nine
