BE IT ORDERED BY THE GOVERNING BODY OF City of Narka, Kansas


Section 1: That the monthly rates and charges for water supplied by the the City of Narka and consumed or used within or outside the city limits will be as follows:

Section 1: A monthly charge of \$20.00 per month for the first 1,000 gallons of water and \$10.00 for each additional 1,000 gallons used. Minimum charge of \$20.00 per month.


Section 2: All ordinances and parts of ordinances in conflict with provisions hereof and hereby repealed.
