GOVERNING BODY OF City of Narka, Kansas


Section 1: That the monthly rates and charges for water supplied by the the City of Narka and consumed or used within or outside the city limits will be as follows:


Section 2: All ordinances and parts of ordinances in conflict with provisions hereof and hereby repealed.


ORDINANCE NO 2025-01

AN ORDINANCE AMENDING ALL PREVIOUS UTILITY RATE ORDINANCES OF SAID CITY OF MUNDEN, KANSAS:


BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MUNDEN, KANSAS:

Section 1. Hereby amended to read as follows:
There shall be and are hereby established utility service charges for the use of and the service supplied by the City of Munden, Kansas, which shall be at the following rates:
(a) For residential sites-
Water \$30.00 per 3,000 gal--\$10.00 overage
Solid Waste \$9.65
Trash Pickup/Haul \$13
Sewer \$7.00
(b) For commercial/church sites-
Water \$30.00 per 3,000 gal--\$10.00 overage
Solid Waste \$17.59
Trash Pickup/Haul \$13
Sewer \$7.00
Section 2. All ordinances and parts of ordinances in conflict with provisions hereof and hereby repealed.
Section 3. This ordinance shall take effect and be in force March 12, 2025.
