

# Knights stopped short of state

Lakeside's dreams of its first boys basketball state tournament appearance were crushed last Saturday.

Quinter dominated its Class 1A-Division I substate final vs. the Knights at Colby, rolling to a 67-42 victory to book a return to the big dance.

Lakeside, which loses six seniors off of this year's squad, finished the year 14-7.

Ryker Remus, Jace Cunningham, Korbin Naasz, Lakota Snyder, Kaden McCoy and Gabe Smith all wore the black and white of the Knights for the last time in Colby.

The Bulldogs (16-6), who finished third at state in 2024, open this year's tournament vs. reigning state champion South Gray (18-4) Thursday at 8:00 in Dodge City.

Quinter will take an eight-game winning streak south.

Last year's appearance was the Bulldogs' first since 2010.

Quinter defeated Burden-Central 57-43 in the quarterfinals, lost 75-48 to Bishop Seabury in the semifinals and bested Olpe 46-32 in the consolation game.

South Gray defeated Seabury 76-63 in the final.

The Northern Plains League was shut out of state tournaments in both genders. Lakeside was the NPL's lone boys finalist. On the girls side, Osborne lost to Quinter and Rock Hills to Troy in 1A-Divisiion I, and St. John's/Tipton fell to Linn in 1A-Division
