a new draft charter ordinance for consideration.

Draft ordinance Section 2 on elections notes, among other things, that in case of a vacancy on the council occurring by reasons of resignation, death or removal from office or city, the council shall appoint an elector to fill the vacancy for the remainder of the term. This must be done within 45 days. In the case any person elected as a council member neglects or refuses to qualify within 30 days after election, the council member shall be deemed to have refused to accept the office and a vacancy shall exist.

In case of a vacancy in the office of mayor, the president of the council shall become the mayor for the remainder of the term and a vacancy shall occur in the office of the council member becoming mayor.

In Section 3, appointment and removal, the new charter ordinance is amended as follows: the governing body may hire and employ a city administrator, police chief and city clerk and enter into an agreement for the services of a city attorney when a vacancy exists. A vote of a majority of all the members of the council may remove

these officers. The mayor shall not have the power to suspend any officer. All other employees will be hired and removed by the city administrator.

Mayor Dan Finnegan said he was against the draft resolution as presented.

"I think you've made some progress," he said. "In my opinion, you really need to think about the mayor's job and duties. You're not giving the mayor any leverage, and I think we needed that last year. And I felt like I proved."

Finnegan raised concerns that "depowering" the mayor is a slippery slope.

Council member Don Panzer responded that he and council member Tyler Renard are in agreement that the draft contains everything they want. Panzer then asked Dinkel if the council could go ahead and vote on it.

Dinkel recommended the council review it, discuss it and make sure everything is in place first.

"I think if you are going to have a mayor, the mayor needs to have some level of authority in an emergency situation," Finnegan said.

He recommended working on the draft in the next two weeks to get something that alerts people that there is a problem here. That, according to Finnegan, would lead to a 6-0 vote.

"I'm going to do my job, and I think I've followed the law," Finnegan said.

Panzer said he doesn't like the way Finnegan conducts himself at meetings. He pointed to Finnegan recently saying he was not reappointing City Attorney Patrick Hoffman when there were five on the council who were in favor of reappointing him.

Renard said Finnegan was the reason for the discontent among the governing body.

"Because I follow the law,"
Finnegan said.

"We've done it the one way forever, and when you show up, we have to change everything" Repard said

everything," Renard said.
"Because I read the law,"
Finnegan said.

"I like what we've got here," Renard said regarding the draft ordinance. "I don't care if we have a 5-1 vote on this. You (Finnegan) will be the one voting against it."

During another brief interaction between Renard and Finnegan, Finnegan dared Renard to call him "a joke." Renard then did so.

"You're a joke," Renard

said.
That was when Council
President Jessica Kootz
stepped in and asked the
council to get back on topic.

She then moved further con-

sideration of the draft ordinance be tabled until June 23. Renard seconded the motion.

rent unit, but would cost about \$11,000.

"They all agree because the unit is 11 years old, it doesn't make a lot of sense to replace the compressor for \$11,000," she said.

The item was not presented for action because Hilbig does not have firm numbers from contractors and suppliers. The ballpark estimate is between \$50,000-\$70,000 to fully replace the unit.

"I didn't have enough information because everyone is working as fast as they can," Hilbig said. "We talked about single units. We're not able to do that because it was not built structurally

to support individual units. We would have to redo duct work and reinforce structure."

Hand recommended as the district moves forward, purchasing HVAC units from the same manufacturer would simplify repairs and access to parts.

• Hilbig discussed the Fastbridge assessments with the board.

She said some grades had students slide into the high-risk category toward the end of the year, which supports the need for an additional interventionist in Kanopolis Middle School.

"It will be so nice to have someone to help focus on the data and provide the interventions with them," Hilbig said.

• Hilbig presented another update for the student handbook for grades K-6.

The board approved a change that stipulates a parent or parent-designee needs to come into the school to sign a student in or out for appointments or when picking up outside of regular pickup or drop-off times.

• The board went into executive session for 30 minutes to discuss non-elected personnel.

Following the session, the board accepted the following hire: Jennifer Uridel, EES, student teacher agreement and kindergarten teacher beginning in January 2026.

The board also accepted

the following resignations: Jessica Endsley, EES, Title I Aide; Laken Vondracek, substitute; Sabrina Bourbon, EES, interventionist; Dan Magie, director of curriculum & instruction.

"Our hope was not to look at purchasing a bus this year, but the timetable on these things keeps getting pushed further and further back," Murphy said.

He said that Transporation Director Jamie Zink was able to secure a reimbursable grant for the bus in the amount of \$41,245.75 and recommended the purchase of a bus from MidWest Transit. The cost of the bus is \$164,981 before the grant deduction.

With the length of time it takes to get a

bus, Murphy said it could be 16-24 months before the district receives it.

The item was unanimously approved.
