You are hereby notified that a motion to find Amanda Chauvin, Mother of the children named above unfit and to terminate parental rights, appoint a permanent custodian, or enter such orders as are deemed appropriate and has been filed. The Court may find the parent is unfit by reason of conduct or condition which renders the parent unable to care properly for the children, the conduct or condition is unlikely to change in the foreseeable future, the parental rights of the parent should be terminated, and permanent custodian should be appointed for the children.
