#### Have you heard about the **Larned Summer Food Ser**vice Program?

Every day, Monday through Friday, during June and July, the Larned Summer Food Service Program prepares and distributes 150-200 breakfast and lunch meals to children in the community from the Methodist Church location in Larned. From 11:30 to 12:30, the place is humming with cars and kids as they arrive,

The Larned Summer Food Service started 10 years ago when Debbie and husband, Eli, heard about the need in church and decided to take action. "This church is a great location. Although it's not a Methodist Church project, we

are utilizing the facility. The space, the kitchen, and the central location are perfect for our needs."

"This is how it works. We make a menu each month in advance. There are certain criteria to follow: meat, grains, fruits, vegetables, and milk. Breakfast must have a grain,
