### Pawnee Plaza

**Affordable Housing for Qualified Persons**



(The Larned Housing Authority is a Non-Profit Corporation) Pawnee Plaza provides affordable housing. The project was completed in 1978, has been very well maintained, and is located at **1801 Broadway, Larned, KS**. There are 40 one-bedroom apartments, four of our units are barrier free. Each apartment is furnished with stove, refrigerator, carpeting and window coverings. The Requirements for Tenancy are that the applicant or co-applicant be 62 years of age or older, handicapped or disabled. The applicant must also pass the screening process. Applicants are screened for criminal history, sexual predator status, and previous rental history. The Applicant must meet HUD's income guidelines. The rent for the apartments is based on income. The rent is approximately 30% of the tenant's monthly income. Allowances are made for qualifying medical expenses in calculating the rent. HUD requires each household to pay a minimum rent of \$25. Laundry facilities are available onsite.

The Apartment complex pays water, sewer, trash, electric, and gas. A security deposit of one month's rent is required. One pet is allowed within regulations. A pet deposit is an additional \$100.

Pawnee Plaza is a Smoke Free Facility.
