This British biker explained. "I began my trip across the U.S. when I landed in New York on the 28th of May. From there, I traveled down to Philadelphia, then to Baltimore, and Washington. Yes, I am by myself, but I have met a number of bikers from various places: New Zealand, Switzerland, the Netherlands, all traveling east to west."

"I believe I have chosen the wrong direction, though, heading east to west, because I am riding against headwinds."

Reporter: What do you think about when you are riding?

Reporter: Where do you stay at night?"

"I have a full camping setup; however, a few times I have been cycling along and someone would say, 'Come stay with us' in a local church or youth center. People have been quite accommodating. And, many towns have bike hostels where I have stayed as well."

"I follow a route on my GPS, and each day, I plan which towns I will be visiting."

"I have seen some incredible landscapes, I have seen the country change from the mountainous to foothills, the open plains, and the changes as I go. I have also observed a few similarities between the US and England. The topography of the UK seems to mirror the landscape of America. I have been genuinely humbled by the kindness of the people shown to me. I will have ridden a long way, like 50 miles or so, and someone will offer me a drink or an invitation."

## San Juan Mexican **Restaurants Shut Down Across Kansas for Owing** Over \$300,000 in Back Taxes

In a sweeping enforcement action across Northwest and Central Kansas, agents from the Kansas Department of Revenue (KDOR) on Tuesday seized the assets of San Juan Mexican Restaurant Inc. and several individuals associated with the business, citing more than \$300,000 in unpaid state

The multi-county operation was executed on July 8 with the assistance of sheriff's departments from Russell, Scott, Thomas, Phillips, Rooks, and Pawnee Counties. Authorities closed six San Juan Mexican Restaurant locations in the following communities: Russell, Colby, Scott City, Phillipsburg, Plainville, and Larned.

KDOR officials reported the total tax debt at \$301,031.29, stemming from unpaid sales tax and liquor drink tax obligations. Tax warrants were also issued for personal income tax liabilities against several individuals linked to the business, including Bernabe A. Lopez, Margarita Lopez, Johnaton Lopez, Santiago Gutirrez, Bernabe K. Lopez, and David Serrato.

Assets seized include on-site cash, all known bank accounts, business inventory, and personal property. Each business was sealed and marked with a public notice indicating closure. According to the release, all confiscated assets will be sold at public auction, with proceeds applied toward the outstanding tax debt.

"The Department of Revenue works extensively with taxpayers in delinquency to reach voluntary repayment agreements," said Aubrey Challquist, KDOR's Taxation Communications Manager. "Only after repeated failed attempts to resolve the matter do we resort to enforcement actions such as

KDOR stated that its goal is to ensure fairness to law-abiding businesses and to recover funds vital for public services like education, highways, and public safety.

The six San Juan restaurant locations impacted

The KDOR release listed 18 tax warrants across multiple counties involving both corporate and personal tax violations. Despite repeated efforts, officials said, the business and its owners failed to comply with Kansas tax laws, leading to this coordinated enforcement effort.

# **County Commissioners Meet with Quivira Water Officials**

Concern Over Rattlesnake Creek Water

St. JOHN-Thursday afternoon, County Commissioners from Pawnee County, Stafford County and Barton County met in St. John with representatives of the Quivira National Wildlife Refuge, U.S. Fish and Wildlife Service and the Kansas Department of Wildlife and Parks concerning the impact of the Rattlesnake Creek Watershed Plan.

The Commissioners from Pawnee and Stafford County had been seeking this meeting for months. Also attending the meeting were representatives of the Kansas Natural Resource Coalition, QNWR manager Kate Brenner, Kansas Department of Agriculture Chief Engineer Earl Lewis and Groundwater District No. 5 Manager Orrin Feril.

At the heart of the discussion are water rights along the Rattlesnake Creek, the management of that water in the Quivira National Wildlife Refuge and the ability of government officials to invoke eminent domain to seize private property as a water right requirement. Another key element is the right of the government bodies to reduce or retire agriculture water rights.

Pawnee County Commissioner Robert Rein was elected chairman for the meeting and concluded that "This is a good first step. We are trying to ensure that what we finally end up with is going to last and is for the benefit of all."
