You are hereby notified that a Motion to Terminate Parental Rights has been filed in this court alleging that the child named above is a Child in Need of Care and requesting the Court find that the mother is unfit by reason or conduct or condition which renders the parents unable to care properly for a child, the conduct or condition is unlikely to change in the foreseeable future and the parental rights of the parent should be terminated.

A hearing on the Motion to Terminate Parental Rights is scheduled for the 4th day of August, 2025, at 2:30 p.m.. At the hearing the Court may issue orders relating to the care, custody and control of the child. The hearing will determine if the father and mother should be deprived of their parental rights and the right to custody of the child.

The parent(s), and any other person having legal custody are required to appear before the Court on the date and time shown, or to file your written response to the petition with the Clerk of the District Court prior to that time.
