On October 5, 1957 she married Everett "PeeWee" L. Eldridge at N. Hollywood, California. He preceded her in death on March 21, 2015.



RESOLUTION NO. 2025 - R - 015

A RESOLUTION CALLING FOR A REFERENDUM ON THE ISSUE OF AMENDING THE EXISTING COUNTYWIDE RETAIL SALES TAX INTENDED FOR THE PURPOSE OF FUNDING HEALTH CARE SERVICES IN PAWNEE COUNTY

WHEREAS, K.S.A. 12-187, et seq., and amendments thereto, authorizes the Board of County Commissioners of the County to submit to the qualified electors of the County the question of levying a retailers' sales tax to be collected by the state department of revenue with revenue therefrom returned and distributed as provided by law within this County; and

WHEREAS, at a special question election previously held on the 18th day of August, 2009, the citizens of Pawnee County overwhelmingly voted to approve the levying of a countywide retailers' sales tax in the amount of one percent (1%) in Pawnee County, Kansas, for the purpose of funding healthcare services in Pawnee County, Kansas; and

WHEREAS, the Board of County Commissioners of Pawnee County, Kansas, has now determined a modified expenditure authority regarding the revenue received from said countywide retailers' sales tax would better serve the public safety needs of the Citizens of Pawnee County.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PAWNEE COUNTY, KANSAS:

Section 1: A special question election shall be held in the manner prescribed by law on the 4th day of November, 2025, for the purpose of submitting to the qualified electors of Pawnee County, Kansas, the question of amending the current levied countywide retailers' sales tax in Pawnee County, Kansas, for the purpose of funding health care services and county-supported public safety operations in Pawnee County, Kansas, in the amount one percent (1%), if approved by a majority of the electors voting thereon, such tax to take effect the 1st day of January, 2026 and to continue as prescribed by law.

Section 2: If approved by a majority of electors voting thereon, such tax shall be subject to all applicable state laws and administrative rules and regulations of the Kansas Department of Revenue. The services of the Department of Revenue shall be utilized to administer, enforce and collect such tax.

Section 3: Should any section, sentence or clause of this Resolution be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections of this Resolution

Section 4: The county election officer shall cause notices to be published of this special question election as provided by law.

Section 5: This resolution shall take effect upon publication in the official county newspaper.

NOW, THEREFORE, BE IT FURTHER RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PAWNEE COUNTY, KANSAS:

The proposition shall appear on the ballot as follows:

Shall the following be adopted?

Shall the one percent (I%) retailer's sale tax currently levied in Pawnee County, Kansas, for the purposes of healthcare services be amended so that the revenue received therefrom can henceforth be utilized for the purposes of both (A) any healthcare services authorized pursuant to subsection (b)(5) of K.S.A. 8-187; and (B) furnishing and equipping county-supported public safety operations deemed necessary by the board of county commissioners of Pawnee County including, but not limited to, the sheriff's department, jail, emergency management and emergency dispatch services, with said amendment to take effect the 1st day of January, 2026, and to continue thereafter as prescribed by law?
