# Commissioners Approve Solar Project

On Monday, August 25, 2025, the Pawnee County Board of Commissioners took Final Action on the Conditional Use Permit Application of Kinsley Solar LLC for a 150 MW Solar Generation Facility with up to 150 MW storage capacity and a separate application of Kinsley Storage Project, LLC of 50 MW of battery storage. Both projects are proposed to be located in the Keysville Town-

Following public comment, the Board voted 3-0 to approve the conditional use permits.

Kinsley Solar LLC and Kinsley Storage Project, LLC are owned by Tenaska, a privately owned energy company with its corporate headquarters in

Omaha, Nebraska. The permit applications were reviewed and approved by the Pawnee County Planning Commission following a public hearing on August 5, 2025. At the public meeting before the Planning Commission, Tenaska advised that Sunflower Electric will be




this proposed project. Based on Sunflower's required lead time, construction on this proposed project will not commence until late 2027 and will take more than a year to

Under current State law, the solar generation equipment is exempt from property taxes for a period of ten years. Battery storage is currently subject to taxation, but there is pending legislation to include the batteries within the definition of exempt property. Pawnee County has not offered, nor agreed to any additional property tax abatements. The land upon which the proposed

facilities will be located will continue to be subject to ad valorem property taxes. The land is currently assessed as Ag land. Once operational the Ad Valorem Real Property Tax will be assessed at the commercial rate.

The company entered into lease agreements with the landowners on which the proposed facilities will be located. The leases are private agreements between the landowners and the company, including the terms of the agreed upon compensation. Private landowners made their own decisions as to whether leasing to any company was
