# Trail Talk

## Watercolors of the Santa Fe Trail on View at the Santa Fe Trail Center

The Santa Fe Trail Center Museum & Research Library is honored to showcase a selection of watercolor paintings by artist Doug Holdread, on loan from the Santa Fe Trail Association (SFTA). Holdread—an artist and historical illustrator based in Trinidad, Colorado—has long been connected to the Trail's story through his evocative scenes and maps that bring 19thcentury travel to life.

Many Trail enthusiasts will recognize Holdread's work from the commemorative calendar produced for the 175th anniversary of the Santa Fe Trail in 1996. Sponsored by the First National Bank of Trinidad, Colorado, the calendar featured 13 original watercolors twelve Trail scenes and one illustrated map—designed to help tell the story of the Santa Fe Trail. Following the project, the bank donated the paintings to the Santa Fe Trail Association, which continues to preserve and share them.

Holdread's career spans illustration, education, and exhibition. He began as an illustrator during his U.S. Coast Guard service and later worked as a television art director and instructor; his paintings have been shown widely, including international exhibitions. That broad experience shows in the watercolors on display—works that pair careful research with a storyteller's touch.

We are grateful to the Santa Fe Trail Association for making this loan possible and for their partnership with us in the stewardship of Trail history. Visitors are invited to see Holdread's paintings in our gallery now; while there's no set closing date, the works will remain on view whenever another special exhibit is not scheduled in this space.

# The Four-Word Phone Scam

This common four-word phone scam could cost you hundreds or thousands of dollars. Here's some expert advice on how to spot and avoid it.

Picture this: You answer the phone, and the caller quickly asks a yes or no question.

The urgency in their voice and the simplicity of the question naturally lead you to respond immediately. In just a matter of seconds, you've become the victim of a four-word phone scam, and that brief exchange could cost you hundreds or thousands of dollars.

A 2024 Trucaller Insights report found that Americans collectively lost over \$25.4 billion to phone scams during the previous 12 months. "This [four-word] phone scam is particularly frightening [because] they simply rely on the human behavior of answering a quick question," says Matthew Shirley, the vice president of client solutions at Fortalice Solutions, a cybersecurity services company. What is the four-word phone scam?

The four-word phone scam involves a recorded voice that asks, "Can you hear me?" when the victim answers the call. The phrase is designed to trick the victim into responding "yes," while the person or computer on the other end records. The scammer can then use the recording to access the victim's accounts; when asked to authorize log-ins, make a major purchase, or sign up for expensive services, the scammer impersonates the victim with the recorded "yes."
