Down Memory Lane

May 22, 1930

It's not common for a child to attend school one full term without being either absent or tardy, but Osborne County boasts three boys who have attended for eight consecutive years without being either. They are Carl Dixon of Columbia School, Wesley Doak of Twin Creek School, and Will Green of Grand View School.

A star mail route has been established between Beloit and Osborne, connecting daily with the route between Salina and Beloit, We now have three mails a day.

May 9, 1935

The two baby alligator at the Home Oil Company this week abandoned their winter hibernation quarters in the station's basement and took to the pool provided for them just north of the Osborne Lumber Co. Approximately 28 inches in length now, the babies have grown 10 inches since going here three years ago.

Many people have amused themselves this week by guessing the weight on the big boulders gathered from the south hills and arranged in a row near the Sunflower Inn. it is said that the smallest one weighs in the neighborhood of 1700 pounds, while the largest weighs well over a ton.

May 9, 1940

The census taken by the assessors show that Osborne county lost 21 in population over 1939, which brings the total down to 10,027, as against 10,048 last year. Among the towns and cities of the county, Alton showed a losss of 7, Downs a loss of 8, while Natoma showed the greatest loss, amounting to 26. Osborne gained 116 and Portis gained 20.

May 10, 1945

Everett Yoxall, popular vo-ag teacher of OHS for the past 8 years, has been hired to teach vo-ag in the Alton school next year. Just as soon as school is out here he plans on modernizing the house on the farm just east of Alton, where he and his family live. Everett has made many friends here both in and out of school who regret very much to have him leave Osborne.

News reached Osborne last week of the finding of Pat Rothenberger's car in Little Rock, Ark. The car was stolen several weeks ago when three escaped prisoners laid in wait at the Rothenberger farm and after tying up Mr. & Mrs. Rothenberger fled with the car and some \$600.

May 18, 1950

A garbage and trash disposal service is being started in Osborne by K.N. Colcher, Downs. His plans are to have two pick up days each week on Tuesday and Friday.

May 19, 1955

Sheldon McFarland tells us that his store will be moved to its spacious and attractive new quarters on South Second next week and that they plan to hold an open house Wednesday evening.

In a board of directors meeting May 14, W.R. "Ward" Johnston was elected to the position of president of the Hardman Lumber Companies. Johnston has been with them since right after World Ward II when the late Dwight Hardman took over the presidency.

May 12, 1960

Kindergarten and first graders boarded a school bus for their trip to Downs, where they rode by train to Beloit. For many of them it was their first train ride.

The three houses on the lots recently purchased by

the high school district as the site for the gymnasium were auctioned to Weldon Quenzer. The Schneider house brought \$730, the Bliss house \$62.50 and the Anderson house \$355. The Bliss house will be torn down for lumber, and the other two will be moved to different locations.

May 6, 1965

Laura Brown, clity clerk of Alton for the past 16 years, resigned. Lillian Welker was appointed as the new city clerk. The new council members are LeRoy Yost, mayor; Forrest Stanfield, Dewey Clausen, Ted Kurtz, Pete Billings and Vern Eaton. Police judge is Pete Oviatt an marshall is John Hulse.

At the recent FFA convention, members of the Osborne FFA chapter received five awards for the Northwest district. Alan Guttery received the district Star Farmer, crops and farm mechanics awards; Larry Pruitt received the sheep award. Roenne won the state award in electricity.

May 7, 1970

The Osborne FFA chapter brought home a first place trophy from the State Agricultural Mechanics contest at K-State. Team members included Mark Robben, Craig Hadley, Terry & Dan Murphy, Scott & Larry Sigle, Corey Lowdon and instructor Marvin Parrack.

Two Osborne attorneys, Don Gregory and Cecil Bloomer awarded the Juris Doctor (JD) degree May 1 at Washburn University, Topeka. The awards were presented at the program which was held for the purpose of awarding in person the degree to those Washburn graduates who have previously earned the Bachelor of Laws (LLB) degree.

May 15, 1975

Doug Ubelaker, FHSU graduate, has been named a social science teacher and assistant coach at OHS for the 1975-76 school year. He has managed a little league baseball team the last two summers and has spent a year working as a meat cutter. Ubelaker graduated from OHS in 1969.

Forty-eight member of the Alton-Osborne Junior High band traveled to Mankato May 3 to take part in the league music fest.

May 15, 1980

Marching band members of OHS will be wearing new band uniforms this fall under action taken last week by the USD 392 Board of Education. The board approved the purchase of 75 new uniforms to replace current uniforms, which are about 17 years old.

R.B. "Lefty" Feld-kamp, Osborne vo-ag instructor, is retiring at the end of the school year after 33 years in education. Feldkamp plans to put down his teaching tools and retire to the farm, and to enjoy some

time hunting and fishing.

May 16, 1985

Participating in the Sand Greens State Golf tournament were Dusty & Marty Wolters, Marvin McCormick, Ron Wonderlich, Chris Anderson and Kevin Kaser. Osborne's team coached by Mike Frewen, finished 11th in the team standing. OHS students bound for state track are Jay Carswell, Troy Miller, Lori Dibble, Kathy Holling and Angie Sloggett. Wayne Wahrman and Tammy Patee are their coaches.

A total of 33 seniors will say goodbye to OHS next week when diplomas are handed out.

May 17, 1990

Osborne Mayor Bryan Byrd wants to move from city hall to the courthouse. Byrd has become the first Osborne county resident to file for the only office to be elected at the county level in this year's November general election. Byrd paid his filing fee to run as a democrat for the Second District County Commission seat.

For the second year in

a row, Kraig Hahn and Shawn Kaser won the MCL Golf tournament two man competition held in Smith Center.

May 11, 1995

Tim Stock, will become the new chief of police in Osborne when Floyd Bose retires from the position July 1.

A new selection of toys awaits young visitors to the Osborne Public Library. they were purchased from proceeds earned in the local Duckwall's store Cute Baby contest.

May 11, 2000

Nathan & Shari Brown, Arlington, are proud to announce the birth of their son, Roxton Jay, born May 1 at the Hutchinson Hospital.

At the Plainville track meet, Joe Mans set a new mark in the 8th grade boys 200m dash at 24.38 breaking Rick Pruden's 24.53 time set in 1985. In the 8th grade girls a four year old record of 12.31 set by Stephanie Corwin fell when Tracey Conway crossed the finish line in 12 flat.
