## **Historic Bristow Cemetery receives** restoration boost from OCCF grant

A cherished piece of Osborne County's history is set to receive a muchneeded restoration, with assistance from a grant awarded by the Osborne County Community Foundation (OCCF) to the Independence Township Cemetery Board. This funding will support the revitalization of head-

stones and markers in the erations of pioneers and historic Bristow Cemetery, a site rich in heritage and community significance.

Bristow Cemetery is the final resting place for some of the region's earliest settlers. With graves dating back as far as 1871, the cemetery has long served as a tangible link to the past — honoring genseveral of Osborne County's founding families. Over time, however, the elements and a dwindling number of descendants to provide upkeep have taken a toll. Cracked headstones, leaning markers, and weathered inscriphave become tions increasingly common.

Many of the families represented in the cemetery no longer have direct descendants in the area. This grant will allow the Independence Township Cemetery board to preserve their legacy and maintain the dignity of this site. Historic cemeteries like Bristow are irreplaceable community assets. They provide a connection to our past and tell the stories of the people who shaped this region. OCCF is proud to support efforts to preserve them for future generations, ensuring that the legacy of Osborne County's early residents is not forgotten but honored with care and respect.
