July 28, 1932

#### July 22, 1937

Perhaps the largest single unit in wheat farming in this vicinity is the three Hazeltine brothers, Clifford, Don and William and their mother, Mrs. Mary Hazeltine, who farm 1,700 acres of wheat south of Cawker City. The finished threshing with a yield of 47,600 bushels of first quality wheat, which would have brought on the local market approximately \$54,000. The Hazeltines use four 20 foot combines, puled by three Caterpillar tractors. Their wheat averaged about 28 bushels an

A very affable old beggar has been greeting local persons this week with a request for three pennies. He announces that he already has two pennies and one token, but lacks the three cents necessary for a cup of coffee.

# July 23, 1942

Just three weeks ago today the First State Bank, Portis, was boldly held up in board daylight by three men, who later were seen with two women, who helped them escape. They got away with over \$2,800, but also had their car riddled with bullets by the unerring aim of Carl Thomas, cashier, with his trusty high powered rifle. Well, in just three weeks to the day, the three men and two women were picked in Denver by police on a tip from the FBI and KBI.

Fire of unknow origin burned the west elevator of the Farmers Union, Alton, Wednesday of last week. The elevator contained about 4,000 bushels of oats and barley, and this to-

open until 7 p.m. Two Osborne firms have blossomed out in the past couple of weeks with new heavy duty Chevrolet rucks. Quenzer Appliance added one to its fleets of trucks and Weldon went to Dallas, Tex., for the specially designed tank to haul the butane gas in. The Bestitt Bottling Co., owned and operated by Lawrence & Jack Green, put the other Chevy into service as a soft drink delivery truck over the widespread territory.

## June 20, 1972

A public meeting was held last Friday evening for the purpose of deciding the next steps to take towards the nine hold grass greens golf course. It was voted to have a delegation present a program to the city council as soon as it was convenient for the council to met.

Recently, the City of Osborne purchased 30 acres of land to use as an industrial site for future development. The land is being slowly developed and now they are pouring cement for the street named Industrial Ave.

## July 21, 1977

County Republican Committee chairman, Don Kiper, Downs, released the official recommendation for Osborne County sheriff last week as being Daryl Thornburg. The recommendation has been sent to Kansas Governor Robert Bennett for consideration before making an appointment to the position.

to cast a line of type in Osborne County has escaped the junk yard fate now coming to most of its kind because of the advent of new newspaper production methods. Cleaned and polished, dressed in its Sunday best, the little Model 10 has found a home for all time to come in the Ryther Antique Printing Equipment museum in the Printing Service building on the University of Kansas cam-

pus, Lawrence. The Blue and Gold Pee Wee teams met for the second time this season at Agra in the finals of the league tournament. The Gold, who beat the Blue earlier, took their first loss of the season as the Blues came out on top 12 to 3.
