Osborne county's economy is running in high gear, according to a nationwide survey of business activity, recently completed. The spendable income of Osborne county residents was, after deduction for personal taxes, more than \$12,202,000, as against the 1964 total of \$11,357,000. The average per household cam to \$5,084, a rise over the prior year's \$4,732.

According to Kansas Crop and Livestock Report Service, Osborne county last year had dairy products valued at \$7,786. This compared with the 1964 income of \$4,931 and a five year average of \$4,365.
