#### Natoma Independent 100 Years Ago June 4, 1925

The 21 students who graduated from Natoma eighth grade were: Edna Brown, Inez Hachmeister, Cleat Stroud, Eula Teasley, Harold Hoskins, Mabel Stroud, Bernadine Schultz, Donald Gamber, Beulah Martin, Audrey Bemis, Isabel Younie, Eleanor Craig, Nadine Howard, Meredith Richards, Esther Graesch, Velma Pruter, Paul Boedeker, Arnold Pfortmiller, Floyd Dawe, Lela Pohlman and Wilhelmina Baack.

The first tent show of the season, the Anderson Bros. Society Circus, was coming to Natoma that week. It was a one ring dog and pony show, with other attractions, including clowns, acrobats, wire walkers and contortionists.

The newly constructed amusement park in Fairport had sold 159 tickets on its opening day, and the platform was packed with dancers.

Lloyd Wineinger was employed at the Blue Line Garage. Lowell Drake had taken a position at the Farmers Implement House.

The Beeson Grocery had a new ice box for keeping their meats cool. It was shipped from an Iowa factory and was put in use that week.

Excavation was being made for a large gas tank



in front of the Motor Service Garage, where a visible gas pump was being put in place. The garage would then operate two pumps.

Otto Pfortmiller had a new Ford roadster, Ray Booth a used coupe and Frank Matheson a used touring car, purchased of the McEwen agency.

McEwen Garage was showing pictures of the oil field south of town by Harry Stull, showing Ed Oswald and his wife and four boys and the 24 oil derricks on his place, as well as a big oil tank. Mr. Oswald appeared in his regular farm clothing, his good fortune not having as yet put him in the aristocratic class.

What is commonly called a "birdie" in golf is a better score than "par." Clarence Christensen made a different kind of "birdie" on the local course. In driving his ball to one of the greens it passed into a tree and killed a bird there. Clarence had the record for this sort of "birdie" on the Natoma links.

### 75 Years Ago June 8, 1950

Natoma was to have a cabinet shop as soon as Jim Parker can move his machinery from Alton and can complete repairs the cement buildings of the old Natoma Lumber company.

Howard's Shoe Shine Parlor moved to the

Crawford Shoe Shop. Howard White had operated the shoe shine parlor in connection with Christy's Barber Shop for a few years.
