Kansas teen killed when UTV overturns

ANDERSON COUNTY-A Kansas teen died in an accident just after 11:30 p.m. on Saturday, June 7th, in Anderson County. The Kansas Highway Patrol reported a 2015 Polaris UTV, driven by 16-year-old Wyatt L. Whitham of Kincaid, was southbound on NW Marshall Road two and one-half miles west of Garnett. The driver attempted to turn east onto NW 1750 Road. The UTV struck the south embankment and overturned onto the driver's side. Whitham was pronounced dead at the scene and was transported to Frontier Medical-Kansas City. Two passengers, a 15-year-old boy and a 14-year-old boy, both from Garnett, were not seriously injured and not transported. (Hays Post)

Man accused of burglary at rural Kansas cell tower

CHASE COUNTY-On Wednesday, June 4th, Lyon County Sheriff's deputies arrested 43-year-old Jeremy Cox on a warrant after a reported burglary of a cell tower at 50th and Camp Creek Road in southeast Chase County, according to a social media report from Chase County Sheriff. The theft occurred on May 8th. Multiple requested charges were forwarded to the Chase County Attorney's Office, including burglary, criminal trespass to a critical infrastructure facility, criminal damage, and theft. Cox is no longer in custody, according to online jail records. The sheriff's office advised Cox's accomplice to go ahead and turn himself in. (Hays Post)

SALINE COUNTY-Law enforcement is investigating a report of a missing Shih Tzu from a home in the 1600 block of Beverly in Salina, according to Salina Police Captain James Feldman. The reporting party told police that they had a delivery of food through DoorDash on June 7th, and a surveillance camera shows the delivery person picking up the dog, but it does not show the person taking the dog. KHP makes arrest after chase through Russell, Ellis Counties

HAYS-The Kansas Highway Patrol arrested a California man on Monday, June 9th, after a chase through Russell and Ellis Counties. At 5:29 p.m., a trooper tried to stop a vehicle driven by Shelby L. Miller, 54, of El Sobrante, California, because the tag indicated the vehicle had allegedly fled from law enforcement in Seward County, Nebraska, earlier on Monday, said Trooper Tod Hileman. The trooper initiated the stop at about milepost 183 of Interstate 70 between Russell and Gorham. At about 5:35 p.m., the trooper lost sight of the vehicle on southbound U. S. Highway 281. Multiple units, including the KHP aircraft out of Hays, were deployed to search for the suspect, Hileman said. At 6:22 p.m., a trooper located the suspect vehicle going southbound on Fairgrounds Road in Ellis County. At 6:31 p.m., the KHP aircraft located the vehicle going eastbound on I-70 at about milepost 182. The vehicle crashed at about 6:33 p.m. in the 600 block of Front Street in Russell, and the suspect was taken into custody. The suspect is facing requested charges of felony fleeing and eluding, reckless driving, resisting arrest, and leaving the scene of an accident, Hileman said. The suspect is also wanted for charges in Nebraska. (Hays Post)

Garvert used the set as an example for his trade show at KEC, and multiple onlookers laughed when they saw the coasters and voted for his booth. The order also boosted his confidence and drive to sell on Etsy.

This past spring, Garvert supplied plaques for the 2025 Kansas State Entrepreneurship Challenge. The committee wanted a wooden version of the Kansas-shaped acrylic award they had handed out in previous years, and reached out to Garvert. It was the first time Garvert operated his

a daunting task to design and model the 40 awards using Fusion 360 (a 3D-modeling CAD software), and Canva. Each one had to be CNC'd out of wood sheets, sanded, laser engraved, varnished, and assembled.

In addition to the awards, 100 custom keychains were also requested, which involved the same designing and manufacturing process as the awards. Despite a busy school schedule and a weekend lost to Prom, he completed the order the night before they were needed. It was challenging, though Garvert stated, "I am glad I took it upon myself and now have experience working on that big of a project."

After tearing his ACL in the summer of 2023, and though it is unrelated to his business, Intricate Customs, Garvert has also designed electronic reaction buttons for the Rooks **County Health Center's** physical therapy department.

Garvert's business can

be found on Etsy, Facebook, and by word-ofmouth through the local community. Through the YEC and KEC recognition, many people contact him for custom projects, and he occasionally posts online when he has new products to offer.

Garvert will soon be leaving Plainville to attend Kansas State University to pursue a bachelor's degree in electrical engineering. He is undecided about whether to try to run his small business after college, which will largely depend on his circumstances at that time. Until then, he has no long-term goals for it. Still, through the last few years, he has gained knowledge in the business world and wanted to say, "I'd like to let the public know how much I appreciated every single order I've received over the past four years. Each one has given me the opportunity to express my creativity and develop new skills for my future."
