Farming and Ranching of County Roads

Farming and Ranching of county road right-of-way is both increasing road maintenance cost and adversely affecting traffic safety. Cultivation reduces the capacity of the ditch and results in poorer drainage and weak sub grade during wet weather. Growing crops and grazing cattle restrict sight lines at intersections and along the roadway and driveways which can contribute to traffic accidents.

The County Commission requests that the farmers help maintain good road drainage and safe roads by refraining from cultivating on the road right-of-way.

The right-of-way is most common back from the existing ditch. If no ditch is present stay back from the edge of the road a distance of 10 feet on minor roads and 15 feet on major roads.

State law makes it unlawful for any reason to farm or ranch the right-of-way with out the proper permitting from the Hamilton County Commission.

As a Commission we do have the authority to recover the cost of restoring the right-of-way, and may exercise that option where ditches have been farmed shut. Crops growing on the right-of-way are legally considered an obstruction and a nuisance and shall be moved like normal vegetation.

City firefighters participated in continuing educational training Saturday, March 23, using an emergency driving simulator brought to Syracuse from the Kansas Fire and Rescue Training Institute.

According to Chief David Stimatze, this trailer has been here before, but with some newer firefighters, he felt like it would be great training and a good refresher for others.

"This was a two-hour commitment from the firefighters," explained Stimatze, "One simulator was a single seat and the other had two seats."

Stimatze explained that in the twoseater, the passenger could alert the driver ments, we revert to what we know and of dangerous situations such as a motorist running a stop sign, or a pedestrian entering the roadway.

As the firefighters got into the seat of the simulator, it was taking the same steps exactly like getting into the actual fire truck. "Making sure your seatbelt is on, we can't get it wrong, rather than train starting the engine, getting flashers going, until we get it right, so it becomes second releasing the engine brake," explained nature," said Stimatze, "We have to get Stimatze. "The pedals operated just like to the emergency fast, but we have to get the truck and even simulated the necessity there safe!"

They were also able to adjust the simulator to the type of vehicle the firefighter was driving. Whether it was an ambulance, the firetruck, a pumper or water truck, even a chief's suburban.

Another unique feature to help with training was to change weather conditions from rain, snow, fog, wind, daylight, or dark. It also gave the drivers repetitions that they need to watch for such as pedestrians, cars along the road, watching drivers at stoplights who may think they have the right of way, even an ambulance entering the roadway.

"When we are in high-stress environthis was an advantage to review," said Stimatze, "In the event of an accident in the simulator, they were able to push a back button to practice the scenario again, unlike in real life," said Stimatze.

GENERAL NOTICE TO CONTROL NOXIOUS WEEDS

The Kansas Noxious Weed Law K.S.A. 2-1314 et seq requires all persons who own or supervise land in Kansas to control and eradicate all weeds declared noxious by legislative action. The weeds declared noxious are: field bindweed, musk thistle, Johnsongrass, bur ragweed, Canada thistle, sericea lespedeza, leafy spurge, hoary cress, quackgrass, Russian knapweed, kudzu and pignut.

Notice is hereby given pursuant to the Kansas Noxious Weed Law to every person who owns or

Failure to observe this notice may result in the County:

viable seed and the vegetative spread of the plant.

Serving a legal notice requiring control of the noxious weeds within a minimum of five days. Failure to control the noxious weeds within the time period allowed may result in the county treating the noxious weeds at the landowners expense and placing a lien on the property if the bill is not paid within 30 days or,

Filing criminal charges for non-compliance. Conviction for non-compliance may result in a fine of \$100 per day of non-compliance with a maximum fine of \$1,500.

The public is also hereby notified that it is a violation of the Kansas Noxious Weed Law to barter, sell or give away infested nursery stock or livestock feed unless the feed is fed on the farm where grown or sold to a commercial processor that will destroy the viability of the noxious weed seed. Custom harvesting machines must be labeled with a label provided by the Kansas Department of Agriculture and must be free of all weed seed and litter when entering the State and when leaving a field infested
