Chairman Lewis called the Meeting to order at 8:30 a.m. with all Commissioners present.

AGENDA: Commissioner Schwerdfeger moved to adopt the Agenda as presented. Commissioner Grilliot seconded the Motion and it was unanimously approved.

PRIOR MINUTES: Commissioner Schwerdfeger moved to approve the September 2, 2025 Commissioners' Meeting Minutes as presented. Commissioner Plunkett seconded the Motion and it was unanimously approved.

Attorney Gale joined the meeting at 8:34 a.m.

PUBLIC COMMENTS: Bryce Barton and Kevin Walter with Alluvial Power, introduced themselves and advised their Company is pursuing the solar farm in our County and they would be available for questions during Steve Phillip's presentation. Next, Alyese Houston discussed concerns of County Road G. She stated there is no gravel on the road and with the berm being left on the side of the road, the water will not drain off causing the road to get extremely slick when it rains. Also, Alyese has asked to have stripes painted on Road 31. There has been several instances when she has had to go into the ditch to avoid a milk truck that was driving in the center of a road on a hill. The Commissioners advised Alyse they are working on a plan for graveling and building the crowns in the roads, will have Frank Burns check into the cost of painting stripes on Road 31, and will also ask the Sheriff's Office to patrol Road 31 more.

COUNTY BUDGET HEARING: Commissioner Lewis opened the Hamilton County 2025 Budget Hearing at 8:46 a.m. There were no public comments. At 8:47 a.m., Commissioner Lewis closed the Budget Hearing. Commissioner Lewis moved that the Hamilton County 2026 budget be approved as published. Commissioner Coleman seconded the Motion and it was unanimously approved.

HAMILTON COUNTY FIRE DISTRICT #1 RNR HEARING & BUDGET HEARING: Commissioner Lewis opened the Revenue Neutral Rate Hearing for Hamilton County Fire District #1 at 8:47 a.m. There were no public comments. At 8:48 a.m., Commissioner Lewis closed Hamilton County Fire District #1 Revenue Neutral Rate Hearing. Commissioner Schwerdfeger moved to approve Resolution No. 2025-6 A RESOLUTION OF THE HAMILTON COUNTY FIRE DISTRICT #1, HAMILTON COUNTY, KANSAS, TO LEVY A PROPERTY TAX RATE EXCEEDING THE REVENUE NEUTRAL RATE. Commissioner Plunkett seconded the Motion. Commissioner Lewis called for a roll call vote with Commissioner Schwerdfeger, Commissioner Grilliot, Commissioner Plunkett, Commissioner Coleman and Commissioner Lewis all voting "aye". Motion passed. Next, Commissioner Lewis opened the Hamilton County Fire District #1 2026 Budget Hearing at 8:48 a.m. There were no public comments. At 8:49 a.m., Commissioner Lewis closed the Budget Hearing. Commissioner Grilliot moved that the Hamilton County Fire District #1 2026 Budget be approved as published. Commissioner Coleman seconded the Motion and it was unanimously approved.

DELINQUENTRURALTRASHACCOUNTHEARING: Commissioner Lewis opened the Delinquent Rural Trash Hearing at 8:50 a.m. There were no public comments. Commissioner Lewis closed the Delinquent Rural Trash Hearing at 8:52 a.m. Commissioner Lewis moved that in order to collect the delinquent solid waste accounts, they be placed on the land owner's property taxes. Commissioner Schwerdfeger seconded the Motion and it was unanimously approved.

DISTRICT COURT: District Court Judge Christopher Velez and Griselda Sigala, District Court Clerk, advised that the Court's computers are still running Windows 10 and will need to be replaced. In October, Microsoft will not provide any support for Windows 10 and the District Court will not allow their computers to be on the Court network due to the security risk. Also, the Judge requested eleven new chairs for the Court offices and Courtroom, which will cost approximately \$4,000.00. There are other capital expenditure requests needed and they presented a list of those requests. Commissioner Coleman moved that the County will contribute \$12,500.00 for the computer and IT upgrades, with the remainder of the capital expenditures will be paid from the Law Library Fund, Diversion Fund or the District Court budget. Commissioner Plunkett seconded the Motion and it was unanimously approved.

STEVE PHILLIPS: Steve discussed the following:

- 1) The pickle ball court lines need to be repainted and he asked Attorney Gale to pay for the painting from the Diversion Fund.
- 2) Presented Agreement No. 404-25 and Project No. AV-2026-45 between the Secretary of Transportation, Kansas Department of Transportation (KDOT), the City of Syracuse and Hamilton County for the Airport's Preservation Project to reseal asphalt pavement cracks on the runway in 2026. Commissioner Lewis moved to sign and accept the Agreement No. 404-25 and Project No. AV-2026-45 between the Secretary of Transportation, Kansas Department of Transportation (KDOT), the City of Syracuse and Hamilton County for the Airport's Preservation Project to reseal asphalt pavement cracks in 2026 on the runway as presented.
