The estimated cost of the Fine Arts Center Improvements is \$5,500,000, and the College expects to utilize the Lease to finance approximately \$3,235,000 of such costs, while using available funds of the College to pay the remaining portion of such cost. The expected total of all payments to be made by the College pursuant to the Lease

and execution and delivery of such legal documents as may be necessary in connection with it, the terms of

If a protest petition signed by not less than 5% of the qualified voters of the College district, as determined by the vote for secretary of state at the last general election, is filed with

the county election officer within 30 days following the last publication of the Resolution, the proposed

Lease shall not take effect unless approved by a majority of the qualified voters of the College voting at an election to be held thereon as prescribed in K.S.A. 10-1116c.
