## **USD 245 to host** groundbreaking ceremony for bond projects

LeROY — The LeRoy-Gridley USD 245 school district will celebrate a major milestone Monday, April 21, with a groundbreaking ceremony marking the start of construction on several voter-approved bond projects. The event will take place at 10 a.m. west of the middle school in Le-

Roy. "This exciting milestone represents countless hours of collaboration, planning, and dedication throughout the bond election process," said Superintendent Matt Thomsen. "We are incredibly grateful to everyone who played a role in bringing this vision to life — from passionate community members to the committed leadership of the USD 245 Board of Education."

# Abendroth chosen to fill District 1 county commission seat

Michael BURLINGTON — Abendroth has been nominated to succeed Tom Hugunin as Coffey County Commissioner for District 1, which includes Burlington Wards 2 and 3.

Hugunin, a Republican in his second term, announced his resignation March 24 after relocating outside the district.

Republican precinct committeemen and committeewomen from the two wards convened April 10 to nominate his replacement. Ward 2 is represented by Brad Jones and Jamie Humlicek; Ward 3 has Denise Humlicek serving as committeewoman, while the committeeman seat is vacant.

individuals-Aben-Three droth, Tim Austin, and Nathan Strawder-submitted letters of interest. Abendroth and Austin made brief statements during the meeting; Strawder was un-

able to attend. After private deliberations, the voting committee selected Abendroth. The nomination was certified, and paperwork was sent Friday to Governor Laura Kelly, who is expected to formally appoint him within seven days.

Abendroth, a local homebuilder and 38-year Coffey County resident, currently serves as chairman of the Coffey County Planning and Zoning Board. He is also a 23-year firefighter and captain with Burlington Station

Abendroth said the county is facing a shortage of "quality built, affordable housing," an issue he hopes to address. "I have added millions of dollars in new home construction to the county tax roll and plan to continue

building homes," he said. He identified additional challenges facing Coffey County, including workforce shortages, limited business growth, and declining civic involvement.

"I am a firm believer that if we support each other, we can overcome challenges and celebrate successes that will make Coffey County a desirable place for people to call home for many generations to come," Abendroth said.

"Our county has the potential to become an even better place for people to call home," he added. "We should always be seeking ways to expand and improve our quality of life for today and the future.'

Abendroth also noted, "I have no agendas or issues with any individuals or business ties which would financially benefit me from my decisions."

Bob Strawder served as chair for the April 10 nominating convention, with Sheriff Tom Johnson acting as secretary. Bill Otto and Ida Wilson tallied the votes.

The District 1 seat will appear on the 2026 general election ballot, along with Districts 4 and 5.

## **New Strawn City Council** approves road project

NEW STRAWN - The New Strawn City Council approved a \$206,090 road asphalt bid and discussed a variety of infrastructure and community issues during its regular meeting April 10 at City Hall.

Council members unanimously accepted a bid from Killough Construction for the 2025 road project, which will cover improvements to Arrowhead Drive and Main Street to Lake Road, as well as a pipe crossing on Fourth Street. Funding will come from the city's infrastructure fund.

In other action, the council approved payment of \$1,374.05 from the sewer fund to Vernon Hess Plumbing for reimbursement related to a property at 430 W. Decker.

Code Enforcement Officer Ray Wards reported progress on nuisance properties. The Myers property on Third Street has improved, and letters will be sent regarding six junk vehicles. Wards is monitoring animal violations and conditions on the north side of the former golf course.

Maintenance Operator Steven Dwight said the city has received one application for summer help and reported that 30 mph speed limit signs have been installed. The city will follow up with Midland Fence Company regarding an existing contract and explore options for installing flagpoles at the city park.

The council also discussed lead and copper water meter responsibilities, utility pedestal regulations, and updates to the city's equipment insurance list. City Attorney Philip Wright will look into legal issues limiting the number and/or placement of utility pedestals.

Clerk Lana Johnson reminded council members to use the city cell phone for official communication outside business hours. She shared updates on **Community Center rentals** and noted QuickBooks support will end May 31. She

gators say Dollison was murdered and his body dumped near Garnett. Scavengers had partially scattered his remains prior to them being found, but investigators recovered bone, hair, tissue and clothing items. He was found wearing a brown corduroy jacket, a green long sleeve button shirt, jeans, a black leather belt with a large belt buckle, brown hiking boots and a navy blue stocking cap. He also wore two gold

rings with crosses, a ring with a number 78 and a silver chain with a large The early 1970s were big times in Kansas City.

Arrowhead Stadium opened in 1972, Worlds of Fun in 1973. The Civella Family ran Kansas City organized crime with heavy involvement not just locally but also in Las Vegas casinos. KCMO was the test lab for a "Preventative Patrol Experiment" in 1972 and 1973, a national law enforcement project testing the theory that increased patrols and visibility of marked police cars and officers could reduce crime in urban areas and reduce fear of crime among the local populations. The experiment had to be stopped and restarted a number of times because some police officers believed the lack of
