A CHARTER ORDI-**EXEMPTING** NANCE THE CITY OF LEROY, **FROM** KANSAS. PORTION OF K.S.A. 15-REMOVING ANY RESIDENCE REQUIRE-MENTS FOR THE CITY ATTORNEY.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LEROY, KANSAS: SECTION 1. The City of LeRoy, Kansas, by the nower vested in it un der Article 12, Section 5 of the Construction of the State of Kansas, hereby elects to exempt itself from the provisions of K.S.A. 15-209 to the extent that statute may require that the City Attorney be a qualified elector of Coffey County, Kansas, or a county adjoining Coffey County, Kansas.

SECTION 2. The City Attorney need not be qualified elector of Coffey County, Kansas, or a county adjoining Coffey County, Kansas, and may reside outside those geographical boundaries. However. those City Attorney shall reside in Kansas.

SECTION 3. The ordinance shall be published once each week for two consecutive weeks in the official city newspaper.

Public Notices SECTION 4. This Charter Ordinance shall take effect sixty-one (61) days after final publication, unless sufficient petition for referendum held on the Ordinance as provided in Article 12, Section 5, Subdivision (c)(3) of the Constitution of the State of Kansas, in which case the ordinance shall become effective if approved by the majority of electors voting thereon.
