County launches comprehensive plan

BURLINGTON — The Coffey County Commission convened for a kickoff meeting with Planning and Zoning Administrator Heidi Harris and representatives from Marvin Planning Consultants, including Keith Marvin, John Shepard, Mason Herman, and Jesse Poore. This marked the start of developing the county's comprehensive plan, which is expected to take 12 to 18 months.

The comprehensive plan aims to guide land use and community

cultural resources, and provide a framework for future decisionmaking. It involves public engagement, data gathering, and extensive analysis of population, housing, economy, transportation, and public facilities.

Public town hall meetings are scheduled for July 14-17 in Lebo, Gridley, LeRoy, and New Strawn, with two additional sessions planned in Burlington and Waverly at the end of July. Residents will

be invited to participate through online and paper surveys, focus groups, and a dedicated project website.

The plan will cover demographics, housing trends, economic strategies, natural resources, public health, safety, utilities, and infrastructure. Preliminary data show stable household numbers despite population decline, highlighting housing needs and economic development opportunities. A comprehensive survey will be available both online and in print, with careful monitoring to prevent duplicate responses. Public input is critical to shaping the plan.

The team will finalize surveys. develop base maps, and gather background data. Draft chapters will be uploaded to the project website for public review.

The meeting concluded with a discussion of future meetings, public outreach strategies, and potential project timelines.

Environmental Health Director Carl Lee gave a brief report on activities from January to April. He issued 16 wastewater permits, completed 10 site appraisals, and conducted inspections and technical assistance related to rural water, wastewater, and land application compliance.

Lee collaborated with state agencies and local officials on environmental planning, participated in

public information meetings and emergency exercises, and updated public resources. Key focus areas included the BU-LA program, CAFO compliance, and public education on mold, radon, and carbon monoxide.

BURLINGTON — The Burlington City Council met Wednesday, May 21, with Mayor Stan Luke presiding. Council members Jerilyn Curtiss, Maxi Berryman, Lila Van Horn, Cara Mays, and Martin Ernst were present; Nathan Strawder was absent. Highlights included departmental updates, a pay raise for an employee, and approval of financial ordinances.

City Clerk Anne Brown introduced Clarissa Foster as the city's new administrative assistant. Chari Bauman, director of the Coffey County Chamber of Commerce, introduced herself, highlighting services offered by the

Chamber. Bauman expressed appreciation that the city offers the Chamber office space rent-free.

☞ Ēlectric (Supt. Alan Schneider): Maintenance included line and equipment upkeep, tree trimming, and generator testing. Monthly DC power supply maintenance was completed in substations.

➡ Water and Wastewater (Supt. Danny Hawkins): A water meter was installed at Fourth and Kennebec. Despite a county drought watch, the city's emergency water plan has not been triggered. The plant produces 550,000 to 575,000 gallons per day. The 1986 dump truck required work.

 Streets (Supt. Mark Davidson): Equipment maintenance was performed, including a minor engine repair. A culvert installation request at Kennebec and Jarboe

GOP picnic showcases conservative vision for Kansas

BURLINGTON — The Coffey County GOP Picnic, held Saturday, May 24, at Riverside West campground at John Redmond Reservoir, drew a number of attendees for an afternoon of political fellowship. Hosted by the Coffey County Republican Central Committee and led by Chairman Bob Strawder, the public event featured prominent conservative voices, including Dr. Jeff Colyer, U.S. Senator Dr. Roger Marshall, and State Representative Brad Barrett.

Two weeks ago, Dr. Colyer, a former Kansas governor and a

fifth-generation Kansan, officially launched his campaign for a return to the governor's office. On Saturday, he emphasized Kansas' need for bold reforms to reverse high taxes, population decline, and lost opportunities for young people. "We need to make Kansas a place where our children and grandchildren want to stay," Colyer said.

Colyer highlighted accomplishments from his previous term, including the elimination of three cabinet agencies, reduction of government jobs, and privatization of Medicaid, which he said saved Kansas over \$1 billion annually
