ELECTION 2025 Deadline passes for city, school board races

A flurry of candidates filed for city and school board positions with expiring terms in the week prior to the deadline at noon Monday, June 2.

Burlington athletes captured five gold medals over the course of the twoday meet, and two runners, seniors Brody Anderson and Keely Hoback, set new meet records in the process.

Anderson is the 2025 state champion in the Class 3A boys' 100- and 200-meter dashes, and he placed first in both the preliminaries and the finals of both events. In the 100-meter dash, the meet record, previously held by Riley County's Jordyn Nelson with a time of 10.63 seconds, was broken in the first heat of the preliminaries by Wichita-Collegiate's Timmy Ritchie with a time of 10.58 seconds, before Anderson broke it again with a time of 10.52 seconds in heat two. In the finals, Anderson lowered the record again with a time of 10.49 seconds, with second-place finisher Ritchie finishing in 10.50 seconds. Per KSHSAA records, the only state 100-meter dash state meet record lower than Anderson's 10.49 seconds is the Class 6A record of 10.36 seconds, set by Wichita Southeast's Mario Ponds in 1996. In the 200-meter dash,

Anderson obliterated the previous record of 21.43 seconds, which was set by Topeka-Hayden's Finn Dunshee in 2024, in the preliminaries with a time of 21.27 seconds and then lowered the record to 21.18 seconds in the finals.

Ritchie, who was again the second-place finisher, finished in 21.46 seconds. Per KSHSAA records, Anderson's time of 21.18 seconds is not only a Class 3A state meet record but also a record across all classes. The next lowest 200-meter

Wyatt updates board on semiconductor project

BURLINGTON — Despite a setback from the U.S. Department of Commerce, Dr. Karl Wyatt told Coffey County Commissioners on Monday that momentum remains Wyatt, Chairman/CEO of SNEAS, Inc., presented a detailed status update during the June 2 commission meeting. He outlined the project's original goal: to construct a facility prosemiconductor suppliers, notably in Taiwan and China.

Hospital CEO requests additional county support

BURLINGTON — Coffey Health System CEO Stacy Augustyn presented the hospital's 2026 budget request and provided key updates to the Coffey County Commission during its meeting May 27.

Augustyn expressed appreciation for the county's continued support, highlighting its recent funding of a new HVAC unit and lab equipment. She noted Coffey County's healthcare advocacy is recognized statewide.

Augustyn confirmed the hospital will discontinue labor and delivery services June 30, citing a \$1.3 million annual loss and declining deliveries. Prenatal and postnatal care will continue through local providers with collaborative regional support, while emergency staff are receiving additional training for potential labor emergencies.

The hospital's current year budget includes total expenditures of approximately \$27.8 million with a projected net loss of \$1.07 million. The hospital received \$2,039,494 in county support in 2025; a 52.5% increase amounting to \$3,111,025 is requested for 2026.

The ambulance service 2025 budget is \$1.87 million, with a projected net loss of \$95,459 in 2025. The ambulance received \$1,021,747 in county support in 2025; an 8.15% increase amounting to \$1,104,994 is requested for 2026.

Augustyn said major

capital projects needed in the near future include purchasing a new ambulance (\$320,000), replacing a hot water heater (\$85,000), and repairing a sewer line under the hospital (\$65,000).

Augustyn said closing the labor and delivery unit will improve cash flow by

Emergency responders work the scene of a one-vehicle, non-injury accident that occurred at 9:16 a.m. Friday, May 30, on Kennebec Street, 300 feet east of Sixth Street in Burlington. Blaze Whitfield Riley, 18, Burlington, was eastbound on Kennebec Street in a 1998 Dodge Ram 1500 pickup, which is registered to Mark Whitfield Riley, Burlington. According to the driver, he was driving east at an estimated speed of 25-30 mph when he believed he was having mechanical issues with his truck. He veered off to the right and came to rest in the south ditch. His truck struck a city utility pole, an MT Networks utility box and fiber optic lines and Brightspeed infrastructure. A Brightspeed phone line was pulled out to a neighboring residence, damaging the siding on the house. Riley was not injured but property damage exceeded \$1,000.
