The festivities kick off Friday evening, July 11, with a 2K/5K Walk/Run beginning south of the high school. Registration starts at 8 p.m., with the race set for 8:30 p.m. More details are available at

Saturday, July 12, brings a Co-Ed Softball Tournament with an 8 a.m. start, along with a free cancer screening from 9 a.m. to noon at the Waverly Community Building. The screening is sponsored by Lodge #224, #7, and the Masonic Cancer Alliance. That night, the entertainment heats up with dueling pianos in the park beginning at 8:30 p.m. Guests are encouraged to bring their own

chairs and enjoy the "Howl at the Moon" performance.

Sunday's events on July 13 start with a biscuit and gravy breakfast at 7 a.m., followed by a morning "Fun Ride" bicycle event with 5-, 10-, and 20-mile routes (Go to ohiodaysrun.wix.com/info for more details). A community church service is set for 10:30 a.m. at the community building, and a potluck dinner will follow at noon. Board hears update on site development, **SSM** status

BURLINGTON — During the June 30 Coffey County Commission meeting, commissioners heard an extensive presentation from Sabin Yanez, engineer with CFS Engineers, regarding the Beto Junction area industrial park site. followed by an update and request from Bart Massey, CEO of Secure Manufacturing Semiconductor (SSM).

Yanez provided an overview of infrastructure considerations and proposed layout changes for the county-owned industrial park property. He emphasized the site's ongoing value as a potential industrial or mixed-use development, despite the federal CHIPS Act project not materializing. Commissioners discussed subdividing the land to accommodate varied development, including preserving tree-lined buffers and incorporating existing lagoons into redefined parcel boundaries.

Yanez recommended planning access roads and utility infrastructure (water, sewer, gas, and roads) based on realistic development projections. He noted progress on a water study, in coordination with the Kansas Water Office, to assess long-term needs and emphasized that the Neosho River Basin is limited in supply. Drawing from Melvern Lake remains a

Dauber promoted to street superintendent ance, awarded for the city's strong

BURLINGTON — The Burlington City Council on July 2 voted to promote Kyle Dauber to Street Superintendent, effective July 7, at a starting wage of \$35.50 per hour. Dauber succeeds Mark Davidson, who retired after more than 37 years working for the city.

In addition to Dauber's promotion, the council approved advertising for a heavy equipment operator to fill Dauber's previous position.

A full council attended the first of two regular July meetings: Jerilyn Curtiss, Maxi Berryman, Lila Van Horn, Cara Mays, Nathan Strawder, and Martin Ernst. Mayor Stan Luke presided at the meeting.

The council approved a \$300 donation to the Coffey County Cancer Support Group for its upcoming 11th annual golf tournament, following a presentation by Mary Ellen Paul.

Angela Trimble, of TrustPoint Insurance, presented a \$30,630.21 dividend check from EMC Insur-

Commissioners approve grant distributions

BURLINGTON — The Coffey County Commission handled a full agenda during its regular meeting Monday, June 30, approving infrastructure distributions, hearing updates, and working on the 2026 county budget.

All commissioners were present for the weekly meeting: Chairman Wayde Thomsen, Steve McCurry, Mike Abendroth, Mark Petterson, and Todd Barker.

Emergency Management Director Amber Presley informed commissioners that her office sub-

mitted a damage assessment for the June 3 flooding event to the Kansas Division of Emergency Management. The total estimated damages include \$83,000 for roads, \$30,000 in debris removal, and \$15,000 for protective measures. The county met its threshold for FEMA reimbursement eligibility and is awaiting a decision based on statewide impacts.

Commissioners approved the second-half distribution of 2025 Park and Recreation Grant funds, totaling \$112,500, and Infrastructure Grant funds totaling \$500,000. The funds were distributed proportionally among the six incorporated cities based on population, with Burlington receiving the largest share.

Following is the breakdown for the Park and Recreation Grants: Burlington - \$54,967.50, Gridley - \$7,290, Lebo - \$18,933.75, LeRoy -\$11,643.75, New Strawn - \$8,178.75, Waverly - \$11,486.25.
