Guest Editorial

"Simon Peter said to him, 'Lord, where are you going?"" John 13:36

In a previous editorial we cited John 21:19 where Jesus says to Peter "Follow me." In the verses immediately preceding that exchange, and over a charcoal fire breakfast, Jesus asks of Peter three times, "Do you love me?" Peter's repeated response to Jesus serves in part to provide a clean slate with regard to his previous failings. Yet even as Peter here experiences forgiveness; it probably causes him to recall those repeated denials of Jesus around another charcoal fire and then to really take stock of his faith and devotion to his risen Lord.

In the 13th chapter of John's Gospel, Jesus identifies for the disciples the marks of authentic discipleship and what will be required to truly follow him. Those include first, a desire to glorify God (vs. 31-32) and second, a willingness to love one another as Jesus has loved us (vs. 34-35)

Now while both of those provisions lend richly with regard to instruction in true discipleship, I want to focus here of what Jesus speaks throughout this passage (vs. 31-38), the essential of following him just as he intends. Thus, if one mark of true discipleship is a desire to glorify God, and a second is an unfailing love for one another; then the all-encompassing mark identified here is an unwavering resolve to follow Jesus. "Peter said to him, 'Lord, why can I not follow you now? I will lay down my life for you. '" (v.37). As Peter would sadly discover, there is a great difference between proclaiming loyalty and practicing loyalty.

It is not without purpose that Luke's Gospel notes that as the soldiers took Jesus out of the Garden "Peter was following at a distance," (22:54) and it was right about there that Peter's real problems began. We might then assume this lesson would serve well the generations to follow; but we'd be wrong. To the contrary, *following at a distance* seems to be pretty much the order of the day for the apostate church as they increasingly ignore the mandates of God's Word, opting instead for the transient approval of worldly wisdom.

I sometimes wonder if they realize how patently absurd is the proposition of *defining for* God that which is *offensive to* God. Yet in more recent times the apostate church has seemed to abandon even the pretense of scriptural authority. Of late they seem invested only in political absurdities, aberrant sexuality, and a spirituality that embraces almost any cause or concern that is diametrically opposed to the authority of the Scriptures.

And all of that got me to wondering why the change? Why now? Why not just go on pretending to honor the Scriptures while continuing to distort or ignore whatever would threaten their tenuous credibility. I believe the heart of the issue centers on their inability to control that which they cannot change.

In the final analysis, perhaps their problem with Scripture is the same difficulty Satan faced with Scripture as cited by Jesus in the wilderness temptations. Simply put; Satan has no power over and can exercise no authority over the Word of God, period! Not then: Not now: Not ever!

As with the responses of Jesus, "It is written" means the words are inviolate, they cannot be altered, ignored, distorted or infringed on by any power above or below! Satan can however, exercise authority over people; any of those, all of those, who choose to "follow at a distance" or perhaps follow not at all. Christian, beware of any such following at a distance; else be prepared to be swallowed up by the world:

If anyone would endeavor to understand the mind of God with regard to abortion; it is in the Book; unmistakably, unequivocally, in the Book. If anyone would endeavor to understand the mind of God with regard to human sexuality; it is in the Book; clearly and graphically delineated in the Book. Anyone aspiring to understand the mind of God as regards glorifying, loving or following Jesus; it's in the Book; graciously, patiently in the Book. Jesus followed the Scriptures without exception; and yes folks, that's also in the Book.

When we consent to follow Jesus, but then only *at a distance* we run the risk of ending up with the wrong crowd. And indeed, that is exactly what happened to Peter. He ended up in the High Priest's courtyard with those who started asking him, "You're one of his followers, aren't you?" Three times he was asked; three times he denied even knowing Jesus. Apparently, Peter found it easier to proclaim loyalty than to practice it!

Are we following in the footsteps of Jesus? Is your life a life that brings alory to God? Is your life one of unwavering resolve to closely follow Jesus? Not only were those appropriate questions for Peter; they are also appropriate questions for us. As in compassionate grace Jesus called out to Peter, "Follow me," so also to each of us does he call, "Follow me." To God be the Glory, Amen and Amen.
