#### 100 Years Ago July 16, 1925

50 Years Ago July 17, 1975

The tax levies in Brown County may be higher in 1925 due to lower taxes paid by the Missouri Pacific, Grand Island and Rock Island railroads, also to smaller returns of money raised under the new tax laws.

The extreme warm weather of the past week has made Burke's Park a popular place and especially the swimming pool. Every afternoon and evening there are many people enjoying the cool water. During the past week there have been people from Hiawatha, Robinson, Highland, Effingham, and other towns as well as hundreds of Horton people in the pool.

A new picture show house on Central Avenue just south of the Scott & Strait Feed Store is practically assured at an early date. It will be built by a group of eight business men, who now own the equipment of the Colonial Theater.

A drive over the streets of Horton reveals a wealth of attractive lawns and many vari-colored flowers in beds of rows about comfortable homes. Seldom has Horton looked so attractive at this time of the year.

#### 75 Years Ago July 13, 1950

Korean Situation-Monday, July 10<sup>th</sup>, the 2<sup>nd</sup> Infantry Division at Ft. Lewis, Washington and other state side troops were alerted to move to the Far East. Tuesday, 11th-U.S. Defense Department called for 20,000 more to be inducted immediately into the Army (240 from Kansas). Wednesday, 12<sup>th</sup>-North Koreans continue to advance despite mount-

#### 40 Years Ago July 24, 1985

Robert Rison, Tri County Manor Administrator since May 1980, resigned on July 9<sup>th</sup>. On Friday July 12<sup>th</sup> he surrendered himself to the Brown County Sheriff and was arrested and was charged with one count of theft. The charges stem from bills of approximately \$300 at motels while attending a seminar in Canada.
