Council member John Atkin noted that he was in favor of the city having a pound but he believed that closing it was the correct decision at this time. Kee noted that the city has a contract with the Allen County Animal Rescue Foundation and they could use that facility in lieu of the current pound.

Waddell and the commissioners said that there is a sign at the location that states the county will not pick trash on the ground after the agreed upon one time clean up discussed last week. It was stated that county never has and, per policy, will not pick up trash off the ground.

Waddell noted that a lot of nonconforming materials such a mattress and lumber were picked up last week. He approached the commission about possibly doing a semi-annual 20 yard dumpster for these types of materials at the sub division.
