Ask Rusty –Social Security Questions Asked Over Coffee

Social Security Matters

**Dear Rusty - My** coffee conversations among a group of friends have resulted in

several questions about Social Security: I. What happens to the Social Security account of someone who dies before retirement age. What hap-

pens to that money and where does it end up? 2. How does the decreased birth rate of the USA affect future Social Security benefits?

3. Is a person who has never contributed to the Social Security System entitled to any benefits from the Social Security Ad-

4. Is there a central location online that a person can access

that explains the history and current status of the Social Security System, that explains all of it in simple terms. I would like to be able to give this location to people I talk with about Social Most of the articles we read are like slogging through mud! I

enjoy AMAC articles and am college educated, but the average reading level in the US is less than 6th grade. Thank you for considering these questions. **Signed: Curious Reader** 

Dear Curious: Thank you for your readership, and I'll be happy to tackle your "over coffee" questions about Social Secu-

1. Social Security is a "pay as you go" program, where all money collected from workers is used to pay benefits for all those who are currently receiving Social Security. In other words, all money contributed is used to pay benefits to others already receiving benefits. It is not put into a separate account for each person, and that is a good thing. Most people get more from Social Security than they ever contributed, but benefits are paid for life, regardless of how long one lives. The specific answer to your question is that if someone dies before retirement age, the money contributed has already been used to pay benefits to others. Keep in mind though, that a surviving spouse or minor or disabled adult child may also collect benefits on a deceased person's Social Security record.

2. The decreasing birth rate in the US hurts Social Security. That's because fewer babies mean fewer future workers contributing to the Social Security program. FYI, in 1950 there were about 15 workers contributing to SS for every one person collecting benefits, but today there are less than 3 workers for each SS beneficiary. That problem is exacerbated by the steadily increasing U.S. life expectancy. Beneficiaries are now often collecting SS benefits for decades from a program designed to pay benefits for only a few years.

3. Only those who have worked and contributed to Social Security through payroll taxes for about 10 years (40 quarters of SS credit) are eligible to collect SS Retirement benefits. However, some dependent spouses and/or dependent minor or dependent disabled children who have never worked might also be eligible for benefits from the worker's Social Security record. Along with each U.S. state, the SSA also administers another program, known as Supplement Security Income (SSI), on behalf of the federal government. However, federal "SSI" benefits are not paid with Social Security funds. "SSI" is a separate government benefit program, with federal benefits paid from the general U.S. Treasury.

4. There are lots of places to get information about Social Security, but I suggest you start at our AMAC Foundation Social Security information website, which can be found at www.socialsecurityreport.org. Here you will find numerous articles about Social Security, retirement, Medicare, etc., as well as all the Ask Rusty articles I have published weekly over the last 8 years. Oh Christian, Have You Been Born Again?

Speaking Truth by Clint Decker

Even though I was a pastor's son and had been in church since I was three, for the first time in my life I was seeking God on my own. One morning as I was praying, suddenly it felt like a flash of light that beamed through my soul. Something had happened to me. I sensed instant peace, joy and love like I had never known. Then while at work I

started weeping as the presence of God came over me. Soon I started listening to preachers on the radio, bought study books to help me better understand the Bible and began talking with others about Jesus, along with many other changes. I had become born again. This idea came from Jesus out of a conversation He had with a man named, Nicodemus. He was a gifted and well-known reli-

gious leader in Israel. He heard lesus teach and became curious, so Nicodemus sought out Jesus saying to Him, "Rabbi, we know that you are a teacher come from God, for no one can do these signs that you do unless God is with him." (John 3:2) Jesus responded, "Truly, truly, I say to you, unless one is born again he cannot see the kingdom of God." (Jn. 3:3). Jesus was aware that Nicodemus, nor His own disciples, had

heard Him speak of this before, so like any of us would have done, Nicodemus asked a very logical question, "How can a man be born when he is old? Can he enter a second time into his mother's womb and be born?" (Jn. 3:4)

Jesus explained how He was using the birth of a child as an illustration, "...unless one is born of water and the Spirit, he cannot enter the kingdom of God. That which is born of the flesh is flesh, and that which is born of the Spirit is spirit." (Jn. 3:5-6) Jesus was communicating how there is human birth (flesh) and there is spiritual birth (Spirit), and for someone to enter the kingdom of God, they must go through a spiritual birth.

What does born again mean? First, it is an illustration of life. All of us were born under the curse of sin, which means we were born spiritually dead. Therefore, to enter the kingdom of heaven we need to come alive. We need the supernatural life of Jesus to come dwell within us. Second, being born again, means that since we have been re-born, we also have become a new person. The new life Jesus has created in us has given a new way of thinking and living. Our values, choices and beliefs have all changed. Third, being born again means we have been re-born by the Spirit, not the flesh. Being re-born is something only God can do. Going to church, getting baptized, taking the eucharist, going through catechism – all those are good things, but they are done by you. You cannot be born again through those efforts, but only by the power of God. Jesus addressed this with Nicodemus, "Do not marvel that I said to you, You must be born again.' The wind blows where it wishes, and you hear its sound, but you do not know where it comes from or where it goes. So it is with everyone who is born of the Spirit." (Jn. 3:7-8)

How can you become born again? Jesus told Nicodemus ...so must the Son of Man be lifted up, that whoever believes in him may have eternal life." (Jn. 3:14-15) Jesus said that He will be lifted up on a cross to die and rise again for all people, and it will be done to provide a way for all who are dead in their sin, to be re-born. And when they turn from their sin and trust in Christ with all their heart, they will be made alive!

A prayer for you — Lord God, I pray for spiritual leaders like Nicodemus and those who regularly attend church. May they humble themselves to examine their hearts if they have been born again, and if they have not, may they call upon you and be changed today. Help them to turn from religion and to Christ. In His name. Amen.

## **Living with Children**By John Rosemond

Q: I hear so much about how kids grow up so fast, how we need to enjoy them when they are young, how they need more one-on-one time, etc. I agree that they grow up fast and that it is important to spend some time with them but I also have house

work and cooking and laundry to do as well as college school work. I feel so much pressure that I should spend all my time with the kids and forget about my other responsibilities but I don't think that's right. How do I balance it all? What amount of attention is good and what amount is bad?

A: Hello! Thank you for your question. It's so true, kids do grow up fast and parents should absolutely enjoy their children. Consider shifting your mindset to enjoying your children at all ages, as each year brings its own unique joy!

While reviewing previous questions and coaching advice, it appears as though you have two children under the age of two. As mentioned by previous coaches, continue to employ Alpha Speech, focus on shifting to Season Two, and don't add additional stress into your life by comparing yourself to other

One-on-one time with kids can look different ways, and can vary from day to day. While trying to balance your responsibilities to your coursework and your household, consider enlisting your children's help and using that time as a teachable moments. After all, preparing healthy meals, completing housework, and having study time are all life lessons that are valuable to pass along to your children, and more than qualifies as quality one-on-one time. In addition, re-organizing your responsibilities might be helpful as well. For example, prepare multiple meals at once on a day you have less coursework and either freeze or refrigerate the rest to use on days when you are more strapped for time. Allow your kids, within reason, to assist with the meal preparation. For example, teaching them to stir ingredients, rinse dishes, or even peel oranges is not only great for their dexterity, but it also provides quality time together. I would also recommend this for cleaning, laundry folding, and a multitude of other household chores. Children typically love to help with adult tasks, and providing appropriate ways to involve them in household responsibilities and chores fall into that "sooner the better" category and provide excellent role-modeling opportunities for self-sustaining life tasks.

Moreover, mentally schedule your college coursework to be completed during nap time. Non-negotiable nap/quiet time should be consistent, giving you daily opportunities to devote to schoolwork. Moreover, clear, concise, and consistent messaging will provide more household structure, including a pretty early bedtime for children their ages. During wake time, providing safe places for children to engage in a sustained amount of play time (without you) would also be advised. For times when coursework requires your attention beyond nap time, giving the children books may be helpful. They'll see you with books, and can have their own book time alongside you, etc.

It's important to give yourself grace, don't attempt to always multi-task, and don't set expectations based on other families. Enjoy every stage of your children. Take time for yourself, go outside with your kids, and go for walks/engage in physical activity as a family. Being your own person will be far more intriguing to your kids than focusing all of your attention on them. Be proud of your independence and aspire to instill that calm, driven, and hard-working attitude in them too. Building independence now will directly impact their resiliency going for-
