

# Kansas Crop Report: Fieldwork Picking Up as Moisture Conditions Hold Steady Week Ending May 4, 2025

Farmers across Kansas made solid progress last week, with 4.7 days suitable for fieldwork, according to the latest report from the USDA's National Agricultural Statistics Service.

**Soil Moisture Conditions**

Topsoil moisture was rated 56% adequate, with 9% very short, 27% short, and 8% surplus. Subsoil moisture followed a similar trend, rated 54% adequate, 13% very short, 29% short, and 4% surplus.

**Winter Wheat Update**

The winter wheat crop showed mostly favorable ratings:

- 40% good
- 33% fair
- 7% excellent
- 15% poor
- 5% very poor

Crop Progress:

87% of winter wheat has jointed (compared to 92% last year and a 5-year average of 80%)

45% is headed (behind last year's 51% but ahead of the 26% average)

**Corn Planting and Emergence**

50% of corn has been planted—on pace with last year and ahead of the 5-year average (43%)

24% has emerged (compared to 27% last year and 18% average)

**Soybeans and Sorghum**

**Soybeans:** 23% planted, with 3% emerged—both slightly ahead of average

**Sorghum:** 4% planted, matching last year and ahead of the 2% average

**Pasture and Range Conditions**

Spring pastures are holding steady, rated:

- 46% good
- 28% fair
- 9% excellent
- 13% poor
- 4% very poor

Farmers continue to monitor crop development closely as weather patterns shift and planting progresses across the region.
